

## LOVE

The **CARE** each child requires upon entering foster care can be overwhelming. In addition to the initial requirements for medical and dental appointments, behavioral health evaluations, court hearings, and numerous other appointments, caregivers are also responsible for getting the child set up in school or day care. Many find it necessary to take time off from work, or quit their jobs entirely to provide the highest quality of **CARE** for the child entrusted to them.

For relatives being asked by the Department of Child Services to take in their kin, the answer is easy. They say "yes" without hesitation because of their deeply rooted **LOVE** for the child in need. They may embark on this journey wanting to believe **LOVE** is "all you need" but are soon faced with the realities of all that this "yes" entails.

HEAL

For a victim of abuse or neglect to **HEAL**, it takes time and a team of dedicated professionals and lay people willing to focus on each individual child's needs. Visits with biological parents, counseling, and therapy are put in place to provide the child and family the means to **HEAL**.

Throughout this process, many kinship foster families find themselves in need of a **BOOST** to help them along the way. We at Boost a Foster Family work tirelessly to provide that needed **BOOST** to kinship families all over our State, making a lasting impact on those families devoting themselves to **LOVE**, **CARE** and **HEAL** the most vulnerable in our communities.

## BOOST

#### Feb, 2014

After discerning foster care for years, Michelle and Bruce Noe begin the foster care process and attend training and are inspired by the kinship families they meet.

#### <sub>o</sub> Aug, 2014

After becoming licensed, the Noes get their first foster care placement.

#### The Noe's foster son lived with them for over 5 years. He went on to graduate from Culinary school and remains a close member of the o Noe family.

#### Shortly after incorporating, Alice Burba and Donna Olson joined the working Board.

#### **July**, 2016

With \$10,000 of seed money, Michelle reconnects with her former licensing worker, Jenny Cook, and starts Boost a Foster Family to support kinship families.

#### June, 2017

After one year of solid service, Boost a Foster Family becomes an AZ **Qualified Foster** Care Organization.

Boost a Foster Family has grown tremendously and now has a \$250,000 budget having served over 3,500 families and 10,000 children since 2016.






