Boost a Foster Family exists to serve low income kinship families in need of safety items and services required by the state of Arizona. We receive referrals from the Department of Child Safety and licensing agencies that are working with kinship families experiencing financial difficulties. We believe that by providing in-kind donations and services, we can remove obstacles that may slow down the licensing process, and at the same time, make the home safer for the family.

Our hope is that our work will help foster children be placed with kin in a timelier manner, avoiding stays in shelters and group homes. Those kinship foster families pursuing licensure will fulfill their state requirements and be granted licenses quicker, thus allowing them to begin receiving much needed resources only available to licensed caregivers.



Get the Tax Credit

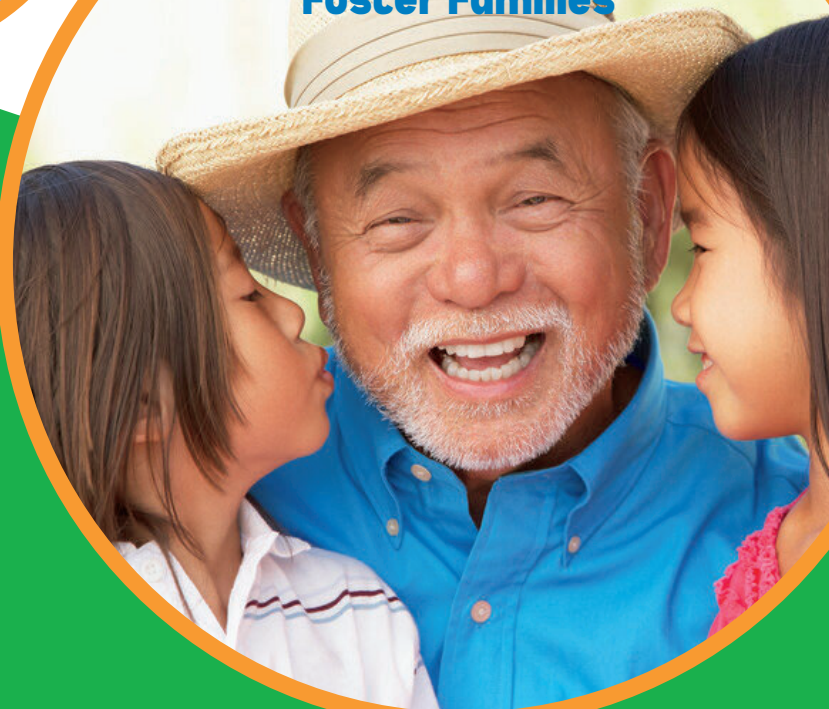
Boost a Foster Family is a 501c3 non-profit and an AZ Qualified Foster Care Charitable Organization QFCO Code: 10043

By providing safety items and services, Boost a Foster Family removes some of the obstacles Arizona kinship foster families experience while at the same time makes homes safe for vulnerable children. Kinship families, especially grandparents, are often on fixed incomes and then have to bear the unexpected expenses of caring for children who are in desperate need of a safe environment, having already experienced the trauma of abuse, neglect, loss and separation.
